We are using a paid Survey Monkey account.

The surveys administered will be sent to Therapist officers in the United States Public Health Service to survey opinions regarding the effectiveness of Therapist Professional Advisory Committee (TPAC) programs. The TPAC is a governing body appointed by the U.S. Surgeon General. The elected, then appointed positions are collateral duty positions representing several agencies throughout The Department of Health and Human Services (HHS). Several committees exist in the TPAC and survey collection is vital for daily business operation. There are approximately 160 officers in the TPAC and the survey will be sent out via our National Institutes of Health (NIH) Therapists listserv as a link, so the response will be anonymous.

No personally identifiable information (PII) will be collected since the survey responses will be anonymous. SurveyMonkey.com is a company that offers powerful web-based survey solutions so organizations of all sizes can gain the insights they need to make more informed decisions. It enables users to create their own web-survey, collect responses, and analyze results using free (e.g., basic) and enhanced paid products and services (e.g., select, gold, and platinum). It is used by survey creators (people who create and conduct surveys on-line) and survey respondents (people who answer those surveys). It allows a user to design a survey using several question formats (e.g., multiple choice, true/false, open-ended) and color palettes, e-mail, and track respondents and export data into Survey and Sampling Analysis/Statistical Package for the Social Sciences SAS/SPSS programs for more complex analysis.

It collects information (personal data, registration/billing information, account settings, address book information, survey data, server web logs, and other data intentionally shared) in order to assess customer satisfaction and/or evaluate the effectiveness of a program. The user can make surveys completely public and indexable by search engines, password protect them, distribute them to a restricted list of people, or choose to share survey responses instantly or at a public location. By default, surveys are anonymous if the survey creator chooses to configure their settings as such. However, specific questions in the survey may still ask an individual to provide personal information or data that could be used to identify them. Anything a respondent expressly discloses in their survey response.

The survey will not collect PII. It will only collect anonymous responses to the survey questions from the public.

Describe the type of PII from the third-party Website or application that will be shared, with whom the PII will be shared, and the purpose of the information sharing:

A link to the survey will be sent out via the NIH Therapist Listserv. Survey responders will click on the link. Only the survey responses will be collected, and the results of the survey will be shared to other Therapists officers. No PII will be collected or shared. The purpose for sharing the survey responses is to assist the committees, subcommittees, and the TPAC leadership with program development.

Upon creation of an account, the user must provide a unique user name and password that must be entered each time the user logs on. A session cookie will record encrypted authentication information for the duration of a specific session.

If PII is shared, how are the risks of sharing PII mitigated?

PII will not be shared. Only the responses to the questions will be shared with other TPAC members.

Will the PII from the third-party website or application be maintained by the OPDIV?

Describe how PII that is used or maintained will be secured:

The TPAC cannot control and protect the content of a survey application distributed by a third party website outside of the Health Resources and Services Administration (HRSA) network. However, the TPAC will post a privacy notice at the top of the survey in the summary section.

Survey Monkey clearly posts on their disclaimer notice that they have no responsibility or liability for the compromise or loss of data, which increases the TPAC's risk.

The survey responses are protected and will be collected anonymously. The results will only be shared with other members of the TPAC, but the PII will be protected and not shared.

What other privacy risks exist and how will they be mitigated?

The link will be sent out via the Listserv, therefore, responses will be collected anonymously to maintain anonymity.
