Introduction

The purpose of this session is to provide Medicare Advantage Organizations (MAOs) and other entities with information on policy and operational guidance on testing and submitting production data to the Encounter Data System (EDS)





MAOs and Other Entities

- CMS requires the following types of organizations to submit encounter data:
 - Medicare Advantage (MA) Plans
 - Medicare Advantage-Prescription Drug (MA-PD) Plans
 - Health Maintenance Organizations (HMOs)
 - Special Needs Plans (SNPs)
 - Local Preferred Provider Organizations (PPOs)
 - Regional PPOs
 - Employer Group Health Plans
 - Programs of All-Inclusive Care for the Elderly (PACE) Plans
 - Cost Plans (1876 Cost HMOs/CMPs and 1833 HCPPs)
 - Medical Savings Account (MSA)
 - Private Fee-for-Service Plans (PFFS)
 - Religious Fraternal Benefit Plans (RFBs)
 - Provider Sponsored Organizations (PSO)

Front-End Certification Compliance Action

- The EDFES testing certification deadline was effective January 3, 2012 for Professional encounter data
- Letters will be distributed by September 7, 2012 to MAOs and other entities that are not compliant
 - These MAOs and other entities are asked to submit any issues, inquiries, or concerns regarding completion of testing and/or certification
 - Indicate the actions your organization intends to perform in order to achieve EDFES certification
- CMS will coordinate with MAOs and other entities to successfully achieve certification





System Volume/ Stress Testing





System Volume/Stress Testing

- Professional files were collected to perform system volume/stress testing on the EDS, which included 147,279 encounters
- Encounters in these files passed CEM level editing and were sent to the EDPS on August 15, 2012
- EDFES edits reported on 999 and 277CA reports were due to errors in submission of:
 - Principal diagnosis codes
 - Diagnosis code
 - Future Date
 - Amount must not be equal to Zero
- Files are currently being processed by the EDPS

Incident Tracking Tool

- As of August 20, 2012, 257 incident inquiries have been received
 - 86% are resolved (219 incidents) and the inquirers notified
 - The remaining 14% (38 incidents) are related to incidents that are being resolved or are under further investigation and analysis
- MAOs and other entities are encouraged to submit incident reports when edits are received on MAO-002 reports





Incident Tracking Tool

- Common or related incidents can be compiled and submitted in one (1) incident report, which will allow the EDS Team to quickly identify, review and assess the issues
- Protected Health Information (PHI) must not be submitted through the Incident Tracking Tool
- Submitters are asked to provide the ICN and include in the description the line number and edit associated with the issue
- If there is more than one (1) ICN associated with a single incident, please submit only one (1) incident report for all associated ICNs

 - MAO-002 Encounter Data Processing Status Report

MAO-001 Encounter Data Duplicates Report

- The MAO-001 Encounter Data Duplicates report provides detailed information on encounters generating edit 98325 – Exact Duplicate of a Service Line within this Claim or a Previously Priced Claim
- Edit 98325 may be generated for one (1) or both of the following two (2) levels of duplicate errors:
 - Service line level within an encounter
 - Encounter level to another previously accepted and stored encounter

DME Testing – EDDPPS Edits

• Six (6) new edits were added to the EDDPPS to correctly process DMEPOS Supplier and DME "incident to" services submissions:

DMETC02 – "Incident to" Services

- In order to properly identify DME Test Case 2 –

 "incident to" services, the test case identifier has been revised:
 - In Loop 2300, CLM01, append "DMETC02" to the end of the Plan Encounter ID (CCN)
- Encounters submitted for DMETC02 that have received an "accepted" status may be resubmitted effective Tuesday, August 21, 2012
- Reminders:
 - From the DME Fee Schedule, select any DMEPOS HCPCS code with a 'JURIS' (column D) = "D"
 - Ensure a Provider NPI is submitted with Payer ID 80881 or 80882
