Surgeons who perform bariatric surgery

# BACKGROUND

Medicare Fee-For-Service and inpatient hospital services cover bariatric surgical procedures. Review provisions in <u>National Coverage Determination (NCD) for BARIATRIC SURGERY for Treatment of Co-Morbid Conditions Related to Morbid Obesity (100.1)</u>.

#### **REASONS FOR DENIAL**

- Insufficient documentation
- Documentation fails to support procedures as reasonable or necessary
- Providers do not comply with signature requirements

# HOW TO PREVENT DENIALS

Beneficiaries must meet the following Medicare coverage criteria:

- Body-mass index (BMI) of more than or equal to 35 kg/m2
- At least one comorbidity related to obesity
- Previously unsuccessful with medical treatment for obesity

Consider the following when billing Medicare for bariatric surgery services:

- Bariatric surgery procedures are performed to treat comorbid conditions associated with morbid obesity
- Types of surgical procedures:
  - **Malabsorptive**—Divert food from the stomach to a lower part of the digestive tract where the normal mixing of digestive fluids and absorption of nutrients cannot occur
  - Restrictive—Restrict the size of the stomach and decrease intake
  - · Both types of procedures can be combined

- Procedures include:
  - Roux-en-Y Gastric Bypass (RYGBP)
    - Gastric restriction and malabsorption; reduction of the stomach to a small gastric pouch (30 cc); open or laparoscopic
  - Biliopancreatic Diversion with Duodenal Switch (BPD/DS) or Gastric Reduction Duodenal Switch (BPD/GRDS)
    - Gastric restriction and malabsorption; the stomach is partially resected, but the remaining capacity is generous compared to that achieved with RYGBP; open or laparoscopic
  - Adjustable Gastric Banding (AGB)
    - Gastric restriction only; a band creating a gastric pouch with a capacity of approximately 15 to 30 ccs encircles the uppermost portion of the stomach; laparoscopic only
  - Sleeve Gastrectomy
    - Sleeve resection of the stomach; open or laparoscopic
  - Vertical Gastric Banding (VGB)
    - Gastric restriction only; the upper part of the stomach is stapled (rarely performed)

Non-covered:

- Treatments for obesity alone
- Supplemented fasting as a general treatment for obesity
- Open adjustable gastric banding
- Open and laparoscopic sleeve gastrectomy (Medicare Administrative Contractors may determine coverage of stand-alone laparoscopic sleeve gastrectomy)
- Open and laparoscopic vertical banded gastroplasty
- Intestinal bypass surgery
- Gastric balloon
