# Risk Adjustment DQAR Overview



#### Data Quality Analysis Reports (DQAR)

- After monthly reinsurance and risk adjustment payment estimates are generated, CMS will send issuers a Data Quality Analysis Report (DQAR)
- These reports are separate from the EDGE Server Outbound Reports and provide issuers with technical summary metrics related to their Risk Adjustment claims selection data and risk score and Reinsurance calculation estimates



### **DQAR** Purpose

- The DQAR helps identify potential technical data problems, such as:
  - Derived values in the outbound reports are incorrectly calculated or are inconsistent with the established CMS risk adjustment methodologies;
  - Accepted claims and enrollment data were incorrectly excluded from the calculations; or
  - Calculated values are understated because of claims and enrollment records that were incorrectly rejected during the file processing edit checks.



## **DQAR** Purpose

- The risk adjustment DQAR will provide issuers with a preview of how their data compares with other issuers with data submitted on the EDGE server.
- \*\*\*Comparative analyses will change as more data comes in\*\*\*
- Issuers may use DQAR reports to determine discrepancies
- CMS may require follow-up with issuers and confirmation of findings based on data summaries in the DQAR



# Risk Adjustment DQAR Content



### **DQAR Content**

- The Risk Adjustment DQAR will consist of one tab:
  - RA DQAR: Issuer Risk Adjustment Summary Report



# DQAR Content: Issuer Risk Adjustment Summary Report

- The initial DQAR for risk adjustment will focus on high level risk adjustment metrics
- RA DQAR tab Indicates:
  - Counts and percentages of claims included in risk adjustment and how they link to enrollees, including claims to enrollee ratios, and counts of diagnoses
  - Quartiles and H, L indicators relative to all issuers in program group for all data elements

# DQAR Content: Issuer Risk Adjustment Summary Report (continued)

- Issuer Risk Score Summary Section:
  - Counts of enrollees in each model, and counts of enrollees with Hierarchical Condition Categories (HCCs)
    - It will also provide diagnosis codes and HCCs per enrollee
  - National average and National Quartile for all data elements

#### DQAR: RA Comparative Data Reliability

- Please note that the RA Comparative Data is only inclusive of issuers with successful risk adjustment runs for the reporting period
- Comparative data may change as more data comes in



#### **Future DQARs**

- Future reports may include additional comparisons for the underlying enrollment, claims, and risk adjustment used in issuers' risk adjustment calculations.
- CMS may run outlier analyses at the issuer level and these analyses will be based on where issuers' data fall within their peer group distribution
- Future reports may also include national and peer group benchmarks (average for all issuers in the group)


- CMS will continue to support Stakeholders through the RA/RI payment calculation estimate process by hosting webinar and user group sessions


