What's Changed? We made no substantive changes to the article other than to update the CR release, effective, and implementation dates; transmittal numbers; and transmittal links.

Action Needed

Make sure your billing staff knows about these changes effective **April 1, 2026**:

- Allowing you to bill HCPCS code P9603 calculated to the 10th of a mile
- How to properly bill to the 10th of a mile
- When to bill using a whole number of miles

Background

Section 1833(h)(3)(B) of the [Social Security Act](#) authorizes Medicare payment for transportation and personnel expenses incurred by trained personnel traveling to collect specimens from eligible Medicare patients. Specifically, we designed this travel allowance to cover costs associated with specimen collection from homebound or non-hospital inpatients.

Key Updates

To provide more accurate reporting and reimbursement for certain travel distances, MACs will update their claims processing systems to allow billing, acceptance, and adjudication of claims submitted with HCPCS code P9603 calculated to the 10th of a mile for claims with dates of service on or after **April 1, 2026**.

P9603 specifically relates to travel allowance for specimen collection, which reimburses transportation costs when collecting specimens from eligible Medicare patients.

The per-mile travel allowance applies in 2 situations:

- The round-trip travel to 1 location is greater than 20 eligible miles for specimen collection from 1 or more patients (payment for the per-mile travel allowance amount, prorated by the number of patients for whom we pay a specimen collection fee)
- When travel is to more than 1 location, regardless of the number of miles traveled

For trips totaling up to 100 eligible miles, round mileage up to the nearest 10th of a mile. Use the decimal in the appropriate place (99.9).

For trips totaling 100 eligible miles or more, round mileage up to the next whole number mile without using the decimal (report 998.5 miles as 999).

For trips totaling less than a mile, enter a 0 before the decimal (0.9).
