Action Needed

Make sure your billing staff knows about National Coverage Determinations (NCDs) with added and deleted ICD-10-CM codes.

Background

CR 14153 announces quarterly changes included in the clinical diagnostic laboratory edit module for October 2025. The NCDs for clinical diagnostic laboratory services were developed by the laboratory negotiated rulemaking committee in 2001. This nationally uniform software was developed and incorporated in the Medicare shared systems so that MACs process laboratory claims for the 23 NCDs in the Medicare NCD Manual, Chapter 1, Part 3, sections 190.12–190.34 uniformly throughout the nation.





MLN Matters: MM14153 Related CR 14153

CMS updates the laboratory edit module quarterly, as necessary, to reflect ministerial coding updates and substantive changes to NCDs. Changes result from coding analysis decisions developed under code maintenance procedures in the negotiated NCDs and ICD-10-CM code biannual updates.
