**What's Changed?** We made no substantive changes to the article other than to update the CR release date, transmittal numbers, and transmittal links.

### Action Needed

Make sure your billing staff knows about updates to National Coverage Determinations (NCDs) with new or deleted ICD-10 diagnosis codes effective January 1, 2026.

### Background

CR 14197 provides a maintenance update of ICD-10 conversions and other NCD-specific coding updates. These NCD coding changes result from newly available codes, separately released NCD coding revisions, or coding feedback received by CMS.

Translations from ICD-9 to ICD-10 aren't consistent 1-to-1 matches, nor are all ICD-10 codes appearing in a complete General Equivalence Mappings mapping guide or other mapping guides appropriate when reviewed against individual NCD policies.

## Key Updates

Relevant coding changes in CR 14197 include:

- NCD 20.16 — Cardiac Output Monitoring by Thoracic Electrical Bioimpedance (TEB)
- NCD 90.2 — Next Generation Sequencing (NGS)
- NCD 110.18 — Aprepitant for Chemotherapy-Induced Emesis
- NCD 190.3 — Cytogenetic Studies
- NCD 210.2 — Screening Pap Smears and Pelvic Examinations for Early Detection of Cervical or Vaginal Cancer
- NCD 210.3 — Colorectal Cancer Screening Tests
- NCD 210.15 — Pre-Exposure Prophylaxis (PrEP) for Human Immunodeficiency Virus (HIV) Prevention
