I. SUMMARY OF CHANGES: The purpose of this Change Request (CR) is to remove logic that assigns obsolete reason codes in the FISS system and to delete records on the reason code file that do not have FISS logic to assign the code. This CR will update the program logic and remove the reason code file records. This CR is part seven (7) of an effort to remove all the obsolete reason codes identified through FISS research.

II. GENERAL INFORMATION

A. Background: The purpose of this Change Request (CR) is to simplify FISS code by removing obsolete, unused reason codes. FISS is working on in-depth analysis of the contents of the Reason Code file. As a result, FISS has identified many obsolete reason codes that were never removed from the FISS program logic as well as reason codes that are on the FISS file that never had program logic to assign them. FISS met with CMS and the MACs to review their findings, and it was agreed that the obsolete codes could be permanently removed from FISS.

This CR is the seventh (7th) in a series to update the FISS system by removing the logic that assigns deleted or long-term inactivated reason codes and to update the reason code file to eliminate unneeded records.

B. Policy: There is no policy impact.
