II. GENERAL INFORMATION

A. Background: The purpose of this Change Request (CR) is to add a field on VMS screens that will display the region. By displaying the region, users will be able to differentiate between test and production regions while they are reviewing, testing, and processing information.

Before the Durable Medical Equipment Medicare Administrative Contractors (DME MACs) transitioned to using Healthcare Integrated General Ledger Accounting System (HIGLAS), the VMS test region was future dated. Because the date displays at the bottom right footer on most VMS screens, users/operators were able to confirm the region by reviewing the date. The test region displayed a future date, and the production region displayed the current date.

Now that both the production and test regions have the dates synchronized, it is difficult to differentiate between the two regions when viewing and updating information. Errors have occurred updating production data instead of test data due to the synchronized date. This will reduce the risk of unintended changes and follow-up revisions by displaying the current working region.
