## 13 I. Introduction

14 The Food and Drug Administration (FDA or Agency) is issuing this draft guidance document to 15 introduce submitters of Q-Submissions (Q-Subs) to the Center for Devices and Radiological Health (CDRH) and Center for Biologics Evaluation and Research (CBER) to the current 16 resources and associated content developed and made publicly available to support certain O-Sub 17 electronic submissions to FDA, specifically Pre-Submissions (Pre-Subs).<sup>1</sup> This draft guidance is 18 19 intended to represent one of several steps in meeting FDA's commitment to the development of electronic submission templates to serve as guided submission preparation tools for industry to 20 21 improve submission consistency and enhance efficiency in the review process.<sup>2</sup> When finalized, 22 this guidance will also facilitate the implementation of the FDA's mandate under section 745A(b) of the Federal Food, Drug, and Cosmetic Act (FD&C Act), amended by section 207 of 23 24 the FDA Reauthorization Act of 2017 (FDARA) (Pub. L. 115-52) to provide further standards 25 for the submission by electronic format, a timetable for establishment of these further standards, 26 and criteria for waivers of and exemptions from the requirements. 27

28 FDA's guidance document "Providing Regulatory Submissions for Medical Devices in

29 Electronic Format — Submissions Under Section 745A(b) of the Federal Food, Drug, and

30 Cosmetic Act" (hereafter referred to as the "745A(b) device parent guidance") provides a 31 process for the development of templates to facilitate the preparation, submission, and review of 32 regulatory submissions for medical devices solely in electronic format. As described in the 33 745A(b) device parent guidance, FDA plans to implement the requirements of section 34 745A(b)(3) of the FD&C Act with individual guidances specifying the formats for specific 35 submissions and corresponding timetables for implementation. When finalized, this guidance 36 will provide such information for Q-Sub electronic submissions solely in electronic format. 37 38 In section 745A(b)(3) of the FD&C Act, Congress granted explicit statutory authorization to 39 FDA to specify in guidance the electronic submissions requirement by providing standards, 40 criteria for waivers and exemptions, and a timetable for such submissions. Accordingly, to the 41 extent that this document provides such requirements under section 745A(b)(3) of the FD&C 42 Act, indicated by the use of mandatory words, such as must or required, this guidance is not 43 subject to the usual restrictions in section 701(h) of the FD&C Act and FDA's good guidance 44 practices (GGPs) regulations, such as the requirement that guidances not establish legally 45 enforceable responsibilities. See 21 CFR 10.115(d). 46 47 This document provides draft guidance on FDA's interpretation of the statutory requirement for 48 electronic submissions solely in electronic format. Therefore, to the extent that this draft 49 guidance describes recommendations that are not "standards," "timetable," or "criteria for 50 waivers" and "exemptions" under section 745A(b)(3) of the FD&C Act, this document does not 51 create or confer any rights for or on any person and does not operate to bind FDA or the public, 52 but does represent the Agency's current thinking on this topic, once final. You can use an 53 alternative approach if the approach satisfies the requirements of the applicable statutes and

54 regulations. If you want to discuss an alternative approach, contact the FDA staff listed on the

- 55 title page of this draft guidance.
- 56

57 To comply with the GGP regulations and make sure that regulated entities and the public

- 58 understand that guidance documents are nonbinding, FDA guidances ordinarily contain standard
- 59 language explaining that guidances should be viewed only as recommendations unless specific
- 60 regulatory or statutory requirements are cited. This draft guidance, when finalized, will contain
- 61 both binding and nonbinding provisions. Insofar as this draft guidance provides "standards,"
- 62 "timetable," or "criteria for waivers" and "exemptions" pursuant to section 745A(b) of the
- 63 FD&C Act, it will have a binding effect when final.
- 64

65 For those provisions not identified as binding, the contents of this document are not intended to

66 have the force and effect of law. This document, other than the binding provisions when

67 finalized, is intended only to provide clarity to the public regarding existing requirements under

the law. FDA guidance documents, including this guidance, should be viewed only as

- 69 recommendations, unless specific regulatory or statutory requirements are cited. The use of the
- 70 word *should* in Agency guidance means that something is suggested or recommended, but not 71 required.

# 73 II. Background

#### **Draft** – Not for Implementation

74 Section 745A(b) of the FD&C Act, amended by section 207 of FDARA, requires that pre-75 submissions and submissions for devices under sections 510(k), 513(f)(2)(A), 515(c), 515(d), 76 515(f), 520(g), 520(m), or 564 of the FD&C Act or section 351 of the Public Health Service Act, 77 and any supplements to such pre-submissions or submissions, including appeals of those 78 submissions, be submitted in electronic format specified by FDA beginning on such date as 79 specified by FDA in final guidance. It also mandates that FDA issue draft guidance not later than 80 October 1, 2019, and a final guidance not later than 1 year after the close of the public comment 81 period, providing for further standards for the submission by electronic format, a timetable for 82 establishment of these further standards, and criteria for waivers of and exemptions from the 83 requirements.<sup>3</sup> 84 In addition, in the Medical Device User Fee Amendments of 2017 (MDUFA IV) Commitment 85 Letter<sup>4</sup> from the Secretary of Health and Human Services to Congress, FDA committed to 86 87 developing "electronic submission templates that will serve as guided submission preparation

- tools for industry to improve submission consistency and enhance efficiency in the review
- 89 process" and "[by] FY [fiscal year] 2020, the Agency will issue a draft guidance document on
- 90 the use of the electronic submission templates." In addition, the MDUFA IV Commitment Letter
- 91 states that "[n]o later than 12 months after the close of the public comment period, the Agency
- 92 will issue a final guidance." The 745A(b) device parent guidance was intended to satisfy the final
- 93 guidance documents referenced in section 745A(b)(3) of the FD&C Act and the MDUFA IV
- 94 Commitment Letter. The Medical Device User Fee Amendments of 2022 (MDUFA V)
- 95 Commitment Letter affirmed FDA's commitment to the continued development of electronic
- 96 submission templates for a variety of premarket submission types.<sup>5</sup>
- 97
- 98 In February 2020, CDRH piloted the use of the electronic Submission Template And Resource
- 99 (eSTAR) electronic submission template by launching the eSTAR Pilot Program.<sup>6</sup> Since that
- 100 time, the development and availability of eSTAR templates, and new versions of those templates,
- 101 has expanded and currently available templates and versions can be found on FDA's website.<sup>7</sup>
- 102
- 103 During the transition time, up to the point when Pre-Sub electronic submissions will be required
- 104 (see Section VI.B below), anyone can voluntarily use eSTAR for submission of Pre-Subs. As
- 105 described below, eSTAR is the only electronic submission template currently available to enable
- 106 Pre-Sub electronic submissions.

## 108 III. Scope

109 This guidance describes the technical standards associated with preparation of the electronic

110 submission template for Q-Subs that enable submission of the electronic Q-Sub solely in

electronic format. Currently, Pre-Subs are the only type of Q-Sub available for electronic

submission. This guidance document will be updated accordingly as other Q-Sub types are

implemented within the eSTAR program. The electronic submission template includes the information and guided prompts FDA believes will best facilitate the collection and assembly of

115 the necessary elements of a 'complete' submission.<sup>8</sup> This guidance is not intended to specify the

user-interface and detailed content of the eSTAR, but instead is limited to establishing the O-Sub

117 electronic format and standards for complying with section 745(A)(b)(3) of the FD&C Act. FDA

118 intends to implement new versions of eSTAR as relevant policies change. FDA also has an

119 ongoing process to collect and consider public comments and stakeholder feedback, which is

- 120 described on FDA's website.<sup>9</sup>

# 122 IV. Significant Terminology

123 For the purpose of this document, the following significant terminology is described:

124125 eCopy: An electronic copy is a duplicate device submission in electronic format of the

126 previously required paper copy submission sent to FDA.<sup>10</sup> An electronic copy is not considered

127 to be an electronic submission, as defined below.

128

129 Electronic Submission (eSubmission): The submission package produced by an electronic

130 submission template<sup>11</sup> that contains the data of a 'complete'<sup>12</sup> submission.

131

132 eSTAR (electronic Submission Template And Resource): An electronic submission

133 <u>template</u><sup>13</sup> built within a structured dynamic PDF that guides a user through construction of an

eSubmission. eSTAR is the only type of electronic submission template that is currently

135 available to facilitate the preparation of Q-Subs as eSubmissions. For simplicity, the electronic

136 submission created with this electronic submission template is often referred to as an eSTAR.

137

138 Electronic submission template: A guided submission preparation tool for industry. An

139 electronic submission template walks industry through the relevant contents and components for

- 140 the respective premarket submission type and device to facilitate submission preparation and 141 enhance consistency, quality, and efficiency in the premarket review process.<sup>14</sup>
- 142
- 143 **PreSTAR:** As of the date of issuance of this guidance document, PreSTAR includes only Pre-
- Sub and 513(g) content, but is a version of eSTAR that will capture other submission types in the future.
- 146
- 147 Structured data: Data and content that are captured in the fields, dropdown boxes, checkboxes,
  148 etc., within the electronic submission template.
- 149
- 150 Unstructured data: Data and content that are submitted as attachments to the electronic151 submission template.
- 152

# 153 V. Current Electronic Submission Template Structure,

## 154 Format, and Use

155 The electronic submission template, eSTAR, is the only currently available electronic

- 156 submission template at this time to facilitate the preparation of Q-Sub electronic submissions.
- 157 eSTAR consists of a collection of questions, text, logic, and prompts within a template that
- guides a user through construction of a 'complete' Q-Sub<sup>15</sup> submission. eSTAR is highly

automated, includes integrated databases (e.g., <u>FDA product codes</u>, <u>FDA-recognized voluntary</u>

160 <u>consensus standards</u>), and includes targeted questions designed to collect specific data and

161 information from the submitter. eSTAR also includes applicable links to regulations, relevant

162 guidances, and other resources for the submitter's reference. Finally, eSTAR is structured to

163 collect and assemble content in the Q-Sub as an electronic submission that closely follows the

- 164 content of the "SMART" Q-Sub review memo template, an internal review tool used by FDA165 reviewers.
- 165

167 Given that an electronic submission properly prepared with an electronic submission template

- 168 should represent a complete submission,<sup>16</sup> eSTAR submissions are not anticipated to undergo a
- refuse to accept (RTA) process. However, FDA intends to employ a virus scanning and technical
- 170 screening process for an eSTAR. A technical screening process is a process for verifying that
- eSTAR responses accurately describe the device(s) (e.g., there are, in fact, no tissue contacting
- 172 components if indicated as such) and that there is at least one relevant attachment per each
- applicable attachment-type question (e.g., a Product Description attachment is included in
- 174 response to the Product Description question).<sup>17</sup> For Pre-Subs, the technical screening process is

175 anticipated to occur within 15 calendar days of FDA receiving the Pre-Sub eSTAR. If the Pre-Sub eSTAR does not pass technical screening, FDA will notify the submitter via email and 176 177 identify the incomplete information, and the Pre-Sub will be placed and remain on hold until additional information is submitted to FDA. If a response (i.e., an updated eSTAR with 178 179 additional information in the applicable sections) is received within the 180-day timeframe, this 180 will be logged in as an amendment to the Q-Sub. If a response is not received within 180 days of 181 the date of technical screening deficiency notification, FDA will consider the Pre-Sub to be withdrawn and the submission will be closed in the system. Upon receipt of the newly submitted 182 information, the review clock will restart at day 0, and FDA staff will conduct the technical 183 184 screening again, following the same procedure, within the first 15 days of the restarted review clock, to assess whether the new information makes the submission complete. When a 185 submission passes technical screening (whether it is the first technical screening or multiple have 186 187 occurred), the review clock continues for the rest of the review process. At this time, FDA will 188 notify the requester electronically and the submission proceeds to substantive review.

### A. Structure of the Current Q-Sub Electronic Submission Template

Table 1 below shows a high-level overview of the structure of the current electronic submission
 template for Pre-Subs,<sup>18</sup> the only Q-Sub type for which eSTAR is currently available, including a
 summary of the anticipated submission content provided by the submitter in each section:<sup>19</sup>

#### **VI.** Electronic Submission Template Waivers, Exemptions, 198 and Timing 199

200 Upon finalization of this draft guidance, all Pre-Subs, including Originals, Supplements, and 201 Amendments, unless exempted below in Section VI.A of this guidance, will be required to be 202 submitted as electronic submissions as of the implementation date. A Pre-Sub that is not 203 provided as an electronic submission as of that date and as described in Section V above, will not 204 be received unless an exemption from the electronic submission requirements applies. 205

#### **Waivers and Exemptions From Electronic Submission A**. **Requirements**

208 Above, FDA identified that Pre-Subs are subject to electronic submission requirements upon 209 finalization of this draft guidance after the implementation date. However, section 745A(b)(2) of 210 the FD&C Act allows for FDA to set forth criteria for exemptions and waivers from electronic submission requirements. FDA has identified such criteria for Q-Subs below. 211

#### 213 Exemptions

- Upon finalization of this draft guidance, FDA intends to implement exemptions for the following 214 215 Pre-Subs/information from the Pre-Sub electronic submission requirements:
- 216 Interactive review responses;<sup>30</sup> •

227	At this time, FDA has not identified any particular circumstances appropriate for a waiver of the
228	Pre-Sub electronic submission requirements and does not intend to grant requests for waiver.
229	Given the widespread availability of software to enable use of the current Q-Sub eSTAR PDF
230	(available to download on FDA's website), all submitters should have the ability to provide a
231	Pre-Sub eSTAR. <sup>33</sup>

### **B.** When Electronic Submissions Will Be Required

As described in the 745A(b) device parent guidance, this draft guidance, once finalized, will be

235 used to specify the corresponding timetable(s) for implementation of Pre-Sub electronic

submissions. FDA intends to provide a transition period of a minimum of one year from the final

237 guidance issuance prior to requiring that all Pre-Subs be provided as electronic submissions.

238 Currently, and during the transition period, eSTARs may be used voluntarily for Pre-Subs. As

instructed at the website for the eSTAR Program (under the heading, "How to prepare a

submission using eSTAR"<sup>34</sup>), the electronic submission must be submitted using FDA's electronic portal when submitting to CDRH. You can submit questions pertaining to the
