AFFINITY GROUP GOALS

- Facilitate peer-to-peer learning through open discussion of strategies, challenges and lessons learned and through sharing of care navigation and care coordination tools.
- Further enhance communication and collaboration amongst care navigators and coordinators established by the CJR Care Navigation Affinity Group (September 2017 to February 2018).
- Gather strategies and lessons learned for sharing with all CJR model participants and for incorporation into the CJR Implementation Toolkit.

SESSIONS – KEY TAKEAWAYS

March 5th Kickoff Session: Centered on strategies for communication and collaboration with post-acute care providers and community organizations. Actions planned by participants: (1) Follow up with SNFs and ask for progress reports; (2) Develop post-acute care plan and goals; (3) Research implementing pre-operative home visits.

May 9th Session 2: Featured an interactive panel discussion with CJR participant hospitals on strategies for managing fracture patients and shared strategies, successes, and opportunities for improvement. Actions planned by participants: (1) Inquire about emergency department case management and SNF CASPER reports; (2) Begin early discharge planning with the families of fracture patients; (3) Work to create a more standardized process for follow-up communication with post-acute care facilities.

July 9th Session 3: Peer Leaders lead discussion on overcoming challenges in care navigation, with a focus on strategies for optimizing patient health prior to surgery. Actions planned by participants: (1) Educating patients to choose high rated SNF facilities; (2) Working to collaborate with SNFs that are not partners; (3) Setting expectations prior to surgery; (4) Changing physician mindset from volume to value.
