#### I. GENERAL INFORMATION

**A. Background:** The purpose of this CR is to develop a new process to facilitate Full Procedure Code Inquiry screen (PL Segment) maintenance in an efficient manner.

Currently, when loading PJ segments for procedure codes associated with audits, the same information (effective date, place of service, etc.) has to be entered one by one for each PJ segment or copied from one to the next individually. This enhancement shall develop a new process to facilitate PL segment related procedure code audit maintenance. A new online screen will be created to give users the ability to add or remove multiple audit related procedure codes to the PL segments by specific procedure code(s) or other criteria such as type of service (TOS) or date of service (DOS). This functionality will be similar to the current MCS D0 maintenance screen for multiple related diagnosis codes.

The SAFE records and maintenance activity transaction records shall capture the maintenance performed from the new screen. There shall be a space on the new maintenance screen to enter a comment. This comment shall be loaded to the SAFE record, as well as all the PL segment.

The System Control Code (SCC) file maintenance activity report, H99R7RPT shall display the maintenance that was performed from the new screen and the clerk ID that initiated the maintenance.
