A. Background: This recurring CR instructs FISS to provide the PS&R system maintainer an updated copybook whenever there are changes to the paid claim file fields. The PS&R system accumulates paid claims data used by Medicare providers to file their Medicare cost reports. FISS paid claim copybook files are needed by the PS&R system/business owner to identify if there are any new/modified Provider Control File (PCF) field locations, which must be captured in the PS&R system for claims loaded after the implementation of FISS's new PCF. It is critical that the PS&R system maintainer is made aware of these changes in a timely manner, as a PS&R system release may be required to capture changes from the PCF.

B. Policy: There is no new legislation associated with this CR.
