

## 1.1 Identity

The following tables below provide a list of acceptable documentation that can be used to verify a consumer's identity. Each document includes an image example, if available, and criteria to help verify the document. A consumer can provide proof of his or her identity by submitting any one of the Tier 1 documents or a combination of the Tier 2 documents detailed in the table.


