This evening, CMS will push out to all standalone PDPs a beneficiary-level file that provides Part D risk scores calculated under the revised 2011 RxHCC risk adjustment model. The file will also provide each enrollees' Part D risk score as calculated under the current RxHCC risk adjustment model, so that you have a comparison.

This memo is to inform you that there may be potential action that is needed for you to accept this new file.

Below is the file layout. The beneficiaries in the file are those who were enrolled in your plan as of July 2009 and who had 12 months of diagnostic data from FFS during the data collection year. If any of your July 2009 enrollees were enrolled in an MA plan during the data collection year, they have been excluded from this file. The 2009 risk scores calculated using the current Part D model have been normalized by the enrollee-based normalization factor of 1.146. The risk scores calculated under the revised Part D model have a 2009 denominator and have been normalized by 1.0.
