SUBJECT: Simulations for Proposed Changes to the Beneficiary Access and Performance

(BAPP) Measure for the C and D Star Ratings

In the 2018 Draft Call Letter, CMS proposes to modify how Civil Money Penalties (CMPs) are used to calculate the BAPP measure for the Medicare Parts C and D Star Ratings. CMS developed contract-level BAPP simulations based on the proposals and is making them available in the Health Plan Management System (HPMS) for informational purposes during the review of the 2018 Draft Call Letter. The simulations rely on the data used for the 2017 Star Ratings and thus, the 2015 measurement year.

The simulations employ the revised methodology detailed in the November 10, 2016 Request for Comments HPMS memo¹ as Option 1 and result in the same deduction for each contract held by a parent organization cited in a CMP notice. The scaled CMP deduction per contract is based on a ratio of the unadjusted CMP amount to total enrollment of the cited contracts at the time of the enforcement action.

For the simulations, the ratio is converted to a deduction using the proposed values below:

Ratio	BAPP Deduction per Cited Contract in the CMP Notice
Under 5.00	10 points
5.00 to less than 10.00	20 points
10.00 to less than 15.00	30 points
15.00 and above	40 points

In addition, the simulations cap the total CMP-related deduction for a contract at 40 points.

Once the revised CMP portion of the BAPP measure is determined for the simulations, the 2017 deductions for the sanction and Compliance Activity Module (CAM) portion are incorporated.

The BAPP measure score was converted to a measure-level star using the cut points in the table below.

1 Star	2 Stars	3 Stars	4 Stars	5 Stars
0, 10 or 20	30 or 40	50 or 60	70 or 80	90 or 100

In HPMS, each contract is provided the information detailed in the table below. The last column of the simulation page is the BAPP measure-level star for a contract.

Please note: The simulation does not reflect the proposed change in the time period for the BAPP measure. The change in the time period was not applied to allow a comparison of the revised BAPP measure to the 2017 Star Ratings received by a contract.
