

## Awards Subject to Climate Resilience and Reduction of Energy and Emissions

### Applicability

This guidance applies to the following covered HHS agency programs that fund the purchase or construction of real property and major renovation projects. It is effective for NOFOs issued after October 24, 2025.

### **Requirements: Tangible Personal and Real Property Reporting**

Covered programs above must include reporting requirements in their NOFOs which fund projects involving a federal interest in [tangible personal property](#) and [real property](#):

- [SF-428](#) (Tangible Personal Property suite of forms (cover page and Attachments), OMB Control Number 4040-0018 (expires 11/30/2024))
- [SF-429](#) (Real Property Status Report suite of forms (cover page and Attachments), OMB Control Number 4040-0016 (expires 2/28/2025))

In addition, covered programs are strongly encouraged to include, or incorporate by reference, best practices for infrastructure to support climate resilience and energy efficiency goals in their NOFOs. Please see below *Guidance: Advancing Climate Resiliency* chart for more details.

### **Background of Requirements and Recommendations**

President Biden created a government-wide approach to address the climate crisis, including [an initiative](#) creating new building codes and standards to boost resilience to the impacts of climate change, lower utility bills for home and businesses, and prioritize underserved communities. Climate resiliency policies, outlined in [Executive Orders \(EO\) 14008](#), Tackling the Climate Crisis at Home and Abroad, and [EO 14057](#), Catalyzing Clean Energy Industries and Jobs Through Federal Sustainability, are a critical part of the Administrations whole-of-government approach to deal with the climate crisis.

HHS Awarding Agencies should invest in real property that meets the “climate-smart infrastructure” criteria for covered programs (see below), as defined by Office of Management and Budget (OMB) Memorandum [M-24-03](#), *Advancing Climate Resilience through Climate-Smart Infrastructure Investments and Implementation Guidance for the Disaster Resiliency Planning Act*.
