Families of trans children sue to halt Texas child-abuse policy

AUSTIN — Three more families with transgender children are suing to block abuse investigations the state has opened against them, <u>adding to the litigation Texas</u> faces after <u>deeming certain gender-affirming medical treatments child abuse</u> earlier this year.

<u>The lawsuit</u>, filed Wednesday in Travis County, asks the court to block the three investigations and any others into families with transgender children who are members of the nonprofit advocacy group for families and allies of LGBTQ people known as PFLAG.

The lawsuit is being led by Lambda Legal and the ACLU of Texas. Along with the families, PFLAG is also a plaintiff.

"Loving and affirming your child and empowering them to be themselves is the highest calling of any parent, no matter your child's gender," Brian K. Bond, executive director of PFLAG National, said in a statement. "If it takes a court ruling to ensure that the law protects families who lead with love in support of transgender Texans, so be it."

This is the <u>second lawsuit</u> targeting the state's February decision to begin investigating certain gender-affirming care as child abuse. That decision was based on a nonbinding opinion from Attorney General Ken Paxton, who said using puberty blockers and hormone therapy to treat gender dysphoria in minors is abuse, and a directive from Gov. Greg Abbott to investigate reports of Texans under age 18 receiving such care.

Lambda Legal and the ACLU <u>filed the first lawsuit in March</u> on behalf of a family whose teen daughter was receiving such care. Last month, the <u>Texas Supreme Court temporarily halted the probe into that family</u>, which has remained anonymous, while the litigation is ongoing. The court also ruled that the governor did not have the authority to force DFPS to undertake such investigations.

Days later, however, DFPS restarted several other investigations into families with transgender children. As of March, they had opened at least nine cases.

The lawsuit filed Wednesday seeks to halt at least three of them.

This latest legal challenge prompted <u>another reaction from the Biden administration</u>, which on Friday again urged LGBT Americans who believe they are the target of discrimination to reach out to the federal government for help.

The Voe and Roe families

Adam and Amber Briggle, who have a transgender son and have been one of the few families to publicly comment on the investigation into their family, are parties to the suit, as are the parents of two other transgender minors who go by the pseudonym Mirabel Voe and Wanda Roe in the lawsuit.

The lawsuit laid out the Voe family's story: Mirabel Voe's transgender son — given the pseudonym Antonio in the lawsuit — started hormone therapy in January and the treatment was improving his mood and anxiety. But the same day Abbott issued his directive, Antonio attempted to commit suicide by ingesting a bottle of aspirin. He was admitted to the hospital.

"Antonio said that the political environment, including Abbott's letter, and being misgendered at school, led him to take these actions," the lawsuit says.

On March 11, the Voe family was visited by Child Protective Services. Mirabel Voe thought that visit might be due to the suicide attempt, the lawsuit states, but she was instead told it was because she was an "alleged perpetrator" of abuse because her transgender son was allowed to access gender-affirming medical treatments.

"The investigator told her that the report of 'child abuse' originated from the outpatient psychiatric facility where Antonio had been seeking help," the lawsuit states.

Wanda's transgender son, called Tommy in the suit, was pulled out of class after Abbott's directive and questioned by a CPS investigator, according to the lawsuit.

"After the interview, Tommy was shaking and upset," the suit stated. "He had missed close to half an hour of class time and did not know what to tell others about why he had been called to the office."

Later that day, the CPS investigator came to the Roe home and asked Tommy's mother and stepfather whether they had ever abused him, forced him to transition or to accept medical treatments associated with his transition. They said no.

The lawsuit stated that Tommy's grades have deteriorated since the interview.

The Briggle family has long been open about their son's transition, attending legislative hearings and political rallies supporting the rights of transgender Texans. In an attempt to breach the political gap, they even had Paxton to dinner in 2016. But the state's new abuse policy has caused them to become fearful for their family's safety.

"For the first time, they have installed cameras outside of their home," the lawsuit reads. "They have been followed in their car, and yelled at by a person in another vehicle."

Trans kids and politics

Age-appropriate and individualized <u>medical treatments for trans youths</u>, including the ones Ken Paxton has called abuse, are supported by the state and nation's largest physicians groups including the American and Texas Medical Associations.

These groups have opposed the state's abuse investigations and other efforts to block or alter gender-affirming care for minors.

Texas' Republican politicians have placed more and more attention on <u>medical treatments for</u> <u>transgender youths</u> in recent months. Last year, state lawmakers debated bills to crack down on genderaffirming health care for minors but failed to pass anything into law.

Then, in November, the first and largest medical program for transgender children in North Texas stopped accepting new patients for treatments like puberty blockers and hormone therapy. A doctor who has sued to successfully resume these treatments while the decision was litigated said it was made under political pressure.

<u>Paxton is seeking to intervene in that lawsuit on behalf of the state.</u>

Paxton's opinion and Abbott's directive were issued a few months later, just weeks before the most competitive GOP primary election season in a decade. Both are seeking reelection, and at the time faced GOP primary challengers who pressured them to target gender-affirming care more aggressively.

Abbott and Paxton easily beat their primary challengers. Both face Democratic opponents in November.

Earlier this year, the <u>transgender investigations prompted the White House</u> to offer help to Texans and other Americans who believed they were being targeted by anti-LGBT policies at the state level. U.S. Health and Human Services Secretary Xavier Becerra reiterated this offer Friday, urging those

discriminated by state agencies receiving federal funds to <u>file complaints with his agency's civil rights</u> <u>office</u>.

"States' attacks on our trans and gender non-conforming youth and their families are dangerous and negligent. It is interference in people's medical decisions and jeopardizes potentially life-saving care," Becerra said in a statement provided to *The Dallas Morning News*. "To anyone who feels targeted or alone in these times, you are not—we see you, and are standing with you."

The Briggles told *The News* last month that they believe the child-abuse investigations are motivated by election-year politics.

"This has been political since day one," said Amber Briggle, who recently welcomed Abbott's Democratic <u>challenger</u>, Beto O'Rourke, to <u>dinner</u>. "They're not going to close [our case] unless they're forced to by the courts."

Families of Trans kids are living in fear of CPS investigation, some leaving TX altogether

Earlier this week, a Houston-area mother of a 17-year-old transgender boy panicked when she heard a knock at her door.

She made sure her children were upstairs, then answered cautiously, fearful the woman outside could be an investigator with the state's child welfare agency. Republican Gov. Greg Abbott ordered the agency last month to investigate parents who help their children transition as potential child abusers.

"It was just like this elderly neighbor who wanted to ask what kind of tree we had in the front yard," said the mother, who asked not to be named out of fear of being targeted. "But my immediate reaction was fight-or-flight mode. Because that's what we're living in right now."

It's moments like these that have convinced her it's time to move her family out of Texas.

"We are at this point moving as soon as we can get our house sold," she said.

Families with transgender children across the state are weighing similar steps after months of increasing political attacks.

Some feel they have been left with an impossible choice: support their children's gender identity and risk losing them to the state, or deny them treatments that the country's largest physicians groups agree is medically necessary and in many cases lifesaving.

Katie Laird, a Houston-area woman who has a 15-year-old transgender son, has been consumed as her "trans mom" support group text thread blew up in recent weeks — first over Texas Attorney General Ken Paxton's assertion that gender-affirming care can be abuse, then over Abbott's directive to Child Protective Services.

"This is now the rest of our year," Laird recalled thinking. She is looking to move her family to Colorado and hopes to return if Democrats can unseat Abbott in November.

National civil rights groups have sued to block the abuse investigations and won a temporary injunction. Paxton says the state is not bound by the ruling while it appeals.

Paxton and other Republicans argue that children are being stripped of their constitutional right to procreate, and that even providing gender-affirming medications may constitute abuse. The Legislature has considered bills to prohibit helping children transition in the last four legislative sessions, but none passed.

"If I think of what it takes to be a loving, supportive parent of a transgender child, to me, everything about it is rooted in listening in love and acceptance, which is the opposite of child abuse," Laird said.

Her son, who asked to remain anonymous to protect his privacy, said it feels like "my entire world is being ripped away from me."

"I feel like after quarantine, especially, that I had a really hard time finding my people and those who actually love me and care for me and seemingly need me to still be alive," he wrote in an email. "And leaving it all for potentially forever makes me cry and overthink and want to curl up in a ball."

Most prominent medical organizations support evidence-based care for treatment of gender dysphoria, which is defined by the American Psychiatric Association as psychological distress and anxiety due to a mismatch between a person's sense of their gender and their assigned sex at birth.

Fights over transgender rights erupted in Texas in 2017 when Republican lawmakers proposed a bill that would compel people to use bathrooms that match their sex assigned at birth.

The bill failed under pushback from LGBT advocates and businesses, but the number of anti-LGBT measures has since ballooned, with more than 70 bills in 2021, adding to a record high in state legislatures across the country, according to bill trackers from the American Civil Liberties Union and LGBT advocacy group Equality Texas.

The 17-year-old's mother said she became more involved with advocacy after her son came out as transgender in 2017. Two years later, they met lawmakers at the Capitol during an event hosted by LGBT rights groups.

She was hopeful then, she said, and believed that if more people could just meet and hear from transgender children, they would "think a little bit harder about the impact of these kinds of bills."

But that optimism quickly died. Some Republican lawmakers told her privately that they did not support bills attacking transgender families, but if one came to the floor, they would be under political pressure to vote for it.

"It felt like it didn't matter what we did," the mother said. "Even if they fully understood the harm they were doing."

As fourth-generation Texans and native Houstonians, she and her husband are reluctant to move, but on top of the threat of an abuse investigation, they've now also found it difficult to obtain prescriptions for their son in the wake of Abbott's directive.

Some providers, including the state's largest pediatric hospital, Texas Children's, have paused services, and the ones that have continued have long waitlists.

"This idea of 'you should just move,' I kind of hate feeding into that," the mother said, noting that not everyone can. "Shouldn't we all be equally safe in any part of the country we live in?" she said.

For her family and others, it was the 2021 legislative session that pushed them to their breaking point. After initial resistance, Republicans leaders passed House Bill 25, which prevents transgender athletes from playing on the team that aligns with their gender identity.

Ricardo Martinez, CEO of Equality Texas, said families of trans children are feeling the effects of "compounded trauma" after that bill took effect in January and Abbott came out with his directive in February.

"We all have moments in time that we remember as pivotal moments that changed us, that made us feel less than," he said. "Transgender kids have had that for 2½ years. What worries me is how much it's going to take for them to undo this damage as adults."

Martinez has been flooded with questions from parents over whether they should pull their kids out of traditional schooling, whether it's safe to go to a doctor's appointment, and whether it's time to leave the state. On leaving, he says he tells them he understands they have to do what they feel is best.

There is a sense of relief on the horizon for the mother of the 17-year-old. She has a friend with a transgender child who already fled the state and looks with awe at the photos she posts online from her new home.

"'Here's us at the park with some friends' or 'Look, today we went to the Children's Museum," she said, describing the captions. "Just normal life pictures, instead of: 'I had to hold my kid all night because he was crying.' I don't even know if I ever saw her smile when she lived in Texas. Now I don't see any pictures where she isn't. I hope that can be us. I hope that can be us soon."



Florida judge has ordered the state's Agency for Health Care Administration (AHCA) to produce documents related to its determination that gender-affirming health care cannot be covered under Medicaid because treatments are "experimental and investigational."

Attorneys for the AHCA — the agency that controls most of the state's Medicaid program — will have until Feb. 14 to hand over documents it has previously argued are protected under attorney-client privilege and work-product privilege.

Those include exchanges between agency officials and "any person" involved in the creation of a June AHCA report that determined available medical literature provides "insufficient evidence" that puberty blockers, hormones and gender-affirming surgeries are safe and effective treatments for gender dysphoria.

The report has been used to bar an estimated 9,000 transgender Floridians from using Medicaid to help pay for gender-affirming health care and was cited during a November meeting between the state's medical boards that

Gender-affirming health care for youths and adults has been deemed safe and medically necessary by most professional medical organizations.

In a six-page order published Tuesday, U.S. District Judge Robert Hinkle said the AHCA must produce, among other documents, its communications with experts that were used to inform the agency's June report on gender-affirming health care and the ensuing rule that excluded treatments from Medicaid. Lawyers for the agency have said that while the desired documents were created for rulemaking purposes, they were also intended for use in litigation they knew would follow the adoption of the rule, making them protected documents by law.

Hinkle said he disagreed.

"Even if this leaves room in an appropriate circumstance for protection of documents created for dual purposes — not just when the primary purpose was to aid in future litigation — the experts at issue here were an essential part of the mandated rulemaking process," he wrote in the order, which is part of an ongoing https://gcc02.safelinks.protection.outlook.com/?url=https%3A%2F%2Fwww.lambdalegal.org%2Fin-court%2Feases%2Fdekker-v-

Hinkle continued, "Either the experts were retained to assist in an honest evaluative process—in which event their communications were not within work-product protection — or the rulemaking process was a sham and the real goal was to prevail in the anticipated litigation — a possibility the defendants could embrace to win the discovery battle only by acknowledging that the rulemaking process was fatally flawed, or nearly so."

Court documents filed earlier this month suggest the state's rulemaking process was just that, with an AHCA employee alleging that the June report "does not present an honest and accurate assessment" of medical evidence and practice guidelines related to gender-affirming health care.

Attorneys for the AHCA must file a revised log of protected documents by Feb. 2, according to Hinkle's order. The plaintiffs in the case — two transgender minors and two transgender adults in their 20s — may file an additional motion to compel if they believe the protected documents are being "improperly withheld."

Florida judge has ordered the state's Agency for Health Care Administration (AHCA) to produce documents related to its determination that gender-affirming health care cannot be covered under Medicaid because treatments are "experimental and investigational."

Attorneys for the AHCA — the agency that controls most of the state's Medicaid program — will have until Feb. 14 to hand over documents it has previously argued are protected under attorney-client privilege and work-product privilege.

Those include exchanges between agency officials and "any person" involved in the creation of a June AHCA report that determined available medical literature provides "insufficient evidence" that puberty

blockers, hormones and gender-affirming surgeries are safe and effective treatments for gender dysphoria.

The report has been used to bar an estimated 9,000 transgender Floridians from using Medicaid to help pay for gender-affirming health care and was cited during a November meeting between the state's medical boards that

Gender-affirming health care for youths and adults has been deemed safe and medically necessary by most professional medical organizations.

In a six-page order published Tuesday, U.S. District Judge Robert Hinkle said the AHCA must produce, among other documents, its communications with experts that were used to inform the agency's June report on gender-affirming health care and the ensuing rule that excluded treatments from Medicaid. Lawyers for the agency have said that while the desired documents were created for rulemaking purposes, they were also intended for use in litigation they knew would follow the adoption of the rule, making them protected documents by law.

Hinkle said he disagreed.

"Even if this leaves room in an appropriate circumstance for protection of documents created for dual purposes — not just when the primary purpose was to aid in future litigation — the experts at issue here were an essential part of the mandated rulemaking process," he wrote in the order, which is part of an ongoing https://gcc02.safelinks.protection.outlook.com/?url=https%3A%2F%2Fwww.lambdalegal.org%2Fin-court%2Feases%2Fdekker-v-

Hinkle continued, "Either the experts were retained to assist in an honest evaluative process—in which event their communications were not within work-product protection — or the rulemaking process was a sham and the real goal was to prevail in the anticipated litigation — a possibility the defendants could embrace to win the discovery battle only by acknowledging that the rulemaking process was fatally flawed, or nearly so."

Court documents filed earlier this month suggest the state's rulemaking process was just that, with an AHCA employee alleging that the June report "does not present an honest and accurate assessment" of medical evidence and practice guidelines related to gender-affirming health care.

Attorneys for the AHCA must file a revised log of protected documents by Feb. 2, according to Hinkle's order. The plaintiffs in the case — two transgender minors and two transgender adults in their 20s —

may file an additional motion to compel if they believe the protected documents are being "improperly withheld."



Leading Health Care Organizations Urge Action to Protect Physicians, Hospitals, Patients and Families from Violence

Groups call on Department of Justice investigation, technology platforms to address harassment and threats of violence against physicians and hospitals

Washington, DC—Today, the American Academy of Pediatrics (AAP), American Medical Association (AMA) and Children's Hospital Association (CHA) unite in support of physicians and hospitals who have been threatened and attacked in recent months.

The groups sent a <u>letter</u> to Attorney General Merrick Garland urging the Department of Justice to investigate the increasing threats of violence against physicians, hospitals and families of children for providing and seeking <u>evidence-based gender-affirming care</u>. The organizations also call on technology platforms to do more to stop the rhetoric that often incites threats or acts of violence and has led to harassment campaigns across the country, much of it directed at children's hospitals and the physicians and staff who work there.

"Whether it's newborns receiving intensive care, children getting cancer treatments or families accessing compassionate care for their transgender adolescents, all patients seeking treatment deserve to get the care they need without fear for their personal safety," said AAP President Moira Szilagyi, MD, PhD, FAAP. "We cannot stand by as threats of violence against our members and their patients proliferate with little consequence. We call on the Department of Justice to investigate these attacks and social media platforms to reduce the spread of the misinformation enabling them."

The AAP and AMA collectively represent more than 270,000 physicians and medical students and CHA represents more than 220 children's hospitals across the country. The groups wrote to Attorney General Garland urging "swift action to investigate and prosecute all organizations, individuals, and entities responsible."

"Individuals in all workplaces have the right to a safe environment, out of harm's way and free of intimidation or reprisal," said AMA President Jack Resneck Jr., MD. "As physicians, we

condemn groups that promote hate-motivated intolerance and toxic misinformation that can lead to grave real-world violence and extremism and jeopardize patients' health outcomes. The AMA will continue to work with federal, state and local law enforcement officials to develop and implement strategies that protect hard-working, law-abiding physicians and other health care workers from senseless acts of violence, abuse and intimidation."

In addition to the letter to the Department of Justice, the groups call on Twitter, TikTok and Meta, which owns Facebook and Instagram, to do more to prevent coordinated campaigns of disinformation. The organizations ask the platforms to take bolder action when false information is shared about specific institutions and physicians. They also urge social media companies to enforce safety and hateful conduct policies to stop the endangerment of patients, families, physicians and health care staff.

"We are committed to providing safe, supportive and inclusive health care environments for each and every child and family, and the clinicians and staff who are dedicated to caring for children," said **CHA President Amy Wimpey Knight**. "Threats and acts of violence are not a solution, nor a substitute, for civil dialogue about issues of a child or teen's health and wellbeing. At CHA, we are committed to working across sectors to prevent misleading and inflammatory comments that result in threats to those caring for patients."

The groups wrote in their letter to Attorney General Garland, "Our organizations are dedicated to the health and well-being of all children and adolescents. We are committed to the full spectrum of patient care—from prevention to critical care. We stand with the physicians, nurses, mental health specialists, and other health care professionals who provide evidence-based health care, including gender-affirming care, to children and adolescents."

Florida judge has ordered the state's Agency for Health Care Administration (AHCA) to produce documents related to its determination that gender-affirming health care cannot be covered under Medicaid because treatments are "experimental and investigational."

Attorneys for the AHCA — the agency that controls most of the state's Medicaid program — will have until Feb. 14 to hand over documents it has previously argued are protected under attorney-client privilege and work-product privilege.

Those include exchanges between agency officials and "any person" involved in the creation of a June AHCA report that determined available medical literature provides "insufficient evidence" that puberty blockers, hormones and gender-affirming surgeries are safe and effective treatments for gender dysphoria.

The report has been used to bar an estimated 9,000 transgender Floridians from using Medicaid to help pay for gender-affirming health care and was cited during a November meeting between the state's medical boards that <u>resulted in a vote to adopt a rule</u> that prevents minors in Florida from accessing gender-affirming treatments.

Gender-affirming health care for youths and adults has been deemed safe and medically necessary by most professional medical organizations.

In a six-page order published Tuesday, U.S. District Judge Robert Hinkle said the AHCA must produce, among other documents, its communications with experts that were used to inform the agency's June report on gender-affirming health care and the ensuing rule that excluded treatments from Medicaid.

Lawyers for the agency have said that while the desired documents were created for rulemaking purposes, they were also intended for use in litigation they knew would follow the adoption of the rule, making them protected documents by law.

Hinkle said he disagreed.

"Even if this leaves room in an appropriate circumstance for protection of documents created for dual purposes — not just when the primary purpose was to aid in future litigation — the experts at issue here were an essential part of the mandated rulemaking process," he wrote in the order, which is part of an ongoing <u>lawsuit challenging Florida's Medicaid exclusion</u>.

Hinkle continued, "Either the experts were retained to assist in an honest evaluative process—in which event their communications were not within work-product protection— or the rulemaking process was a sham and the real goal was to prevail in the anticipated litigation— a possibility the defendants could embrace to win the discovery battle only by acknowledging that the rulemaking process was fatally flawed, or nearly so."

Court documents filed earlier this month suggest the state's rulemaking process was just that, with an AHCA employee alleging that the June report "does not present an honest and accurate assessment" of medical evidence and practice guidelines related to gender-affirming health care.

Attorneys for the AHCA must file a revised log of protected documents by Feb. 2, according to Hinkle's order. The plaintiffs in the case — two transgender minors and two transgender adults in their 20s — may file an additional motion to compel if they believe the protected documents are being "improperly withheld."

On March 2, 2022, the Office for Civil Rights (OCR) within the Department of Health and Human Services (HHS) issued new guidance on civil rights protections for transgender youth, their families, and providers that offer gender-affirming health care services. The guidance explains how attempts to restrict access to gender-affirming care, or disclose patient information about this care, could violate federal nondiscrimination protections such as Section 1557 of the Affordable Care Act (ACA) and the Health Insurance Portability and Accountability Act (HIPAA), among others. OCR strongly encourages patients and providers who have faced discrimination to file a complaint here.

OCR was not alone in taking action: other HHS divisions also issued guidance or resources on protecting and supporting transgender young people and their families. For instance, the HHS Administration for

Children and Families issued a separate memorandum to agencies that serve LGBTQ young people in the child welfare system. HHS's announcements were highlighted in a statement from President Biden focused on responding to attacks on transgender youth and their families by leaders in Texas.

What Is Happening In Texas?

The OCR guidance itself does not name Texas, but statements from President Biden and Secretary Becerra do. Why the emphasis on Texas? On February 22, Governor Abbott directed the Texas Department of Family and Protective Services (DFPS), the state's child welfare agency, to investigate parents and providers in instances where a child receives gender-affirming care as "child abuse." Governor Abbott's directive is based on an advisory opinion from Attorney General Paxton that identifies medical procedures and treatments that he asserts qualify as "child abuse" under Texas law.

Under the directive, certain licensed professionals (e.g., doctors, nurses, teachers, etc.) and members of the general public are asked report any known instance of this "abuse"—or face penalties for the failure to do so. DFPS and other state agencies were also directed to follow the Attorney General's opinion. (Parts of the directive are reminiscent of Texas' law restricting abortion access, known as S.B. 8, where people are asked to report their neighbors and friends to the authorities for seeking highly personal health care services.)

Attorney General Paxton's advisory opinion grossly misstates the evidence base for gender-affirming care and repeatedly misrepresents this type of care as elective. As discussed below, every major medical association has affirmed that gender-affirming care is medically necessary to treat gender dysphoria. The advisory opinion also distastefully compares gender-affirming care (the provision of which is highly individualized and done in conjunction with a child's medical team) to our nation's horrific legacy of forced sterilization.

Investigations And Lawsuits

Gov. Abbott's directive has already sparked investigations by state officials into the parents of transgender young people and providers. One family was visited by DFPS on February 25 for interviews, only days after the directive was issued, and asked for access to their child's medical records.

On March 1, this family, along with a clinical psychologist, sued Governor Abbott and DFPS in state court. The plaintiffs are represented by the ACLU and Lambda Legal. In their complaint, the plaintiffs noted that the directive has caused "terror and anxiety ... and singled out transgender youth and their families for discrimination and harassment." They went to great lengths to describe the medical standards in place for transgender youth by heavily citing clinical guidelines from the Endocrine Society and the World Professional Association for Transgender Health (WPATH). They also explained that puberty-delaying treatment is reversible and does not cause infertility (contrary to assertions in the advisory opinion) and underscored the benefits and strong evidence base for gender-affirming care.

On March 2, a Texas judge blocked DFPS from investigating the plaintiffs by issuing a temporary restraining order against the agency. This protects these parents and provider, but the court's order is limited only to those plaintiffs already under investigation. The court did not set aside Governor Abbott's entire directive, at least not yet—the court scheduled a hearing for March 11 to assess whether to block the directive more broadly.

A Note On Gender-Affirming Care

It is the overwhelming consensus among medical experts that gender-affirming care is medically necessary, effective, and safe when clinically indicated to alleviate a medical condition known as gender dysphoria (formerly known as gender identity disorder). According to the American Medical Association, untreated gender dysphoria "can result in clinically significant psychological distress, dysfunction, debilitating depression and, for some people without access to appropriate medical care and treatment, suicidality and death." Contrary to Attorney General Paxton's views, numerous studies and meta-analyses—including a comprehensive literature review on the issue—have demonstrated the significant benefits of gender-affirming care. This data and evidence base is cited in the lawsuit noted above.

WPATH has long maintained a set of evidence-based standards of care for transgender people. And experts on minor health like the American Academy of Pediatrics, the American Academy of Child and Adolescent Psychiatry, the American Counseling Association, the American Psychiatric Association, the American Psychological Association, the Endocrine Society, the National Association of Social Workers, the Pediatric Endocrine Society, and the Society for Adolescent Health and Medicine have issued statements and guidelines in support of access to care for transgender people, including young people. There are a range of clinical care programs that provide age-appropriate gender-affirming care for young people across the country, without the devastating impacts that Texas officials claim.

Major payers also view gender-affirming care as medically necessary. In a recent letter to federal officials, AHIP emphasized its strong support for "ensuring that appropriate gender-affirming care is available and accessible to enrollees." This is in addition to prior support for full nondiscrimination protections for LGBTQ people. Fortune 500 companies and state Medicaid programs have also adopted clear policies to require the coverage of gender-affirming care.

OCR's Guidance

OCR's guidance from March 2 underscores the importance of medically appropriate and necessary gender-affirming care for transgender young people and explains how efforts to restrict access to this type of care, like those announced by Texas, could violate federal civil rights laws and privacy protections. Care denials, restrictions on care, and reporting on those who access care could violate Section 1557 of the ACA, Section 504 of the Rehabilitation Act, the Americans with Disabilities Act, and HIPAA. OCR urges families and providers who have faced discrimination to file a complaint with OCR.

Per OCR, attempts to restrict or characterize gender-affirming care as "abuse" are dangerous, can discourage providers from offering this life-saving care, and will negatively affect the health and well-being of transgender and gender nonconforming youth. Overall, the goal of the guidance is to help ensure that young people can access care without discrimination and to respond to fear from families and providers about attempts to portray gender-affirming care as "abuse."

Section 1557 is the ACA's primary nondiscrimination provision and applies to any program or activity that is administered by a federal agency or any entity established under Title I of the ACA. Under Section 1557, an individual cannot be excluded from participation in, denied the benefits of, or subjected to discrimination based on race, color, national origin, age, disability, or sex by any health program or activity of which any part receives federal financial assistance. Per prior guidance from 2021, HHS interprets sex discrimination to include discrimination based on sexual orientation and gender identity.

What does sex discrimination mean in the context of actions like those in Texas? First, federally funded entities covered under Section 1557 cannot categorically refuse to treat someone based on their gender identity. Thus, someone cannot be turned away from care, including gender-affirming care, just because they are transgender. Second, covered entities cannot restrict a person's ability to receive medically necessary gender-affirming care solely because of their gender identity or sex assigned at birth. Efforts to restrict this type of care—by, say, preventing a doctor from providing or prescribing gender-affirming care—likely violate Section 1557.

As an example, a doctor or staff member that reports a parent or child to state authorities—after, say, the family comes in for a consultation for gender-affirming care—may violate Section 1557 if the doctor or facility receives federal financial assistance. Patients who have been denied care based on gender identity or providers who have been restricted from providing care based on a patient's gender identity can file a complaint with OCR.

Section 504

There may be further, independent protections for transgender young people under Section 504 of the Rehabilitation Act and Title II of the Americans with Disabilities Act. Section 504 prohibits discrimination based on disability in programs or activities that receive federal financial assistance, and Title II protects qualified individuals with disabilities from discrimination in state and local government programs. Gender dysphoria may qualify as a disability under these laws. Thus, restrictions that prevent individuals from accessing medically necessary care based on gender dysphoria, a gender dysphoria diagnosis, or perceived gender dysphoria may also violate Section 504 and Title II of the ADA.

HIPAA

HIPAA, among other provisions, requires health care providers and other entities to protect sensitive patient health information from being disclosed without a patient's consent or knowledge. Here, OCR cautions that disclosing protected health information—such as a patient's receipt of gender-affirming care—without a patient or guardian's consent may violate HIPAA. Said another way, HIPAA prohibits the disclosure of protected health information about gender-affirming care without consent except in limited circumstances.

One of these limited circumstances—where disclosure may be possible without a patient's consent—is when disclosure is required under another law. Here, OCR reminds covered entities that HIPAA permits, not requires, disclosure without consent. OCR also notes that the "required by law" exception is narrow, both in when it is required and the scope of the disclosure. Disclosure is permissible when "required by law" only in response to "a mandate contained in law that compels an entity to make a use or disclosure of PHI and that is enforceable in a court of law." Examples outlined in federal regulations include court orders, subpoenas or summons, grand jury requests, or lawsuits. The scope of the disclosure is also narrow and should be limited only to the relevant requirements of the law; disclosures that go beyond what is required may violate HIPAA.

OCR's guidance serves as a reminder that covered entities are merely permitted (not required) to disclose a patient's protected health information without their consent, including in response to Gov. Abbott's directive. The lawsuit noted above also argues that neither Gov. Abbott's directive nor Attorney General Paxton's advisory opinion are legally binding and that this new purported definition of

"child abuse" is inconsistent with state law, was not adopted using proper procedures, and is unconstitutional. These arguments raise real questions about whether any disclosure of sensitive patient information about gender-affirming care is truly "required by law" for purposes of this narrow HIPAA exception (and in general), such that providers and others should feel compelled to comply with it.

Overall, OCR cautions covered entities against voluntarily reporting protected health information related to gender-affirming care to state authorities except in the narrowest of circumstances and only when truly compelled to comply with a legally enforceable requirement. Providers who are concerned about their reporting obligations should seek legal advice. As with the statutes noted above, OCR encourages families to file a complaint with OCR if there has been a violation of a patient's health privacy rights.

Remedies

Complaints are important to enable OCR to investigate and enforce the laws noted above based on specific facts and circumstances. While the agency has other tools (such as compliance reviews), complaints will help OCR target its action, conduct thorough investigations, and maximally enforce federal laws. Complaints could also inform forthcoming rulemaking on Section 1557.

Specific complaints will also make clearer which federal laws apply to a given situation. While the laws cited above—Section 1557, Section 504, Title II, and HIPAA—are broad and powerful, they vary in scope, and each may not apply in every circumstance. In the context of Section 1557, questions about the scope of the law are exacerbated by dueling regulatory interpretations over who qualifies as a covered entity. There could, for instance, be questions about whether these laws theoretically apply to DFPS itself—whereas a specific complaint could underscore why these federal laws apply.

Setting aside these types of questions, OCR makes clear that federal protections apply to health care providers that receive federal funding. Medical facilities, for instance, should not direct doctors or staff to stop providing gender-affirming care or turn patients away. If OCR received a complaint about a situation like this, what might happen? The remedy would depend on the circumstances, but OCR would investigate and work to achieve voluntary compliance (through, say, a resolution agreement). Absent voluntary compliance, a violation of these laws would enable OCR to take enforcement actions such as levying financial penalties, terminating federal funding, or referring the entity to the Department of Justice for further legal action.

There is prior precedent for investigating state agencies in response to complaints about discrimination. A prominent recent example was a dispute between HHS OCR and California. In 2020, OCR issued a notice of violation to California, asserting that a state law requiring health insurance plans to cover abortion violated federal conscience protections. OCR later moved to disallow \$800 million annually in California Medicaid funds, an action that now-Secretary of HHS (then-Attorney General of California) Becerra defended against. You can see other examples of action against state agencies, albeit under different laws, in recent resolution agreements in Alabama, Pennsylvania, and Oregon.

The Biden administration may also have other options at its disposal to protect transgender youth, although it is not clear what would be the most effective. Among other options, the Administration for Children and Families could open a compliance review for DFPS. That could lead to an improvement plan and potentially financial penalties. The Department of Justice could try to sue Texas, as the agency recently did over S.B. 8; alternatively, the department could at least file a "statement of interest" in the

pending litigation, as it has done in other litigation on gender-affirming care for young people, such as the lawsuit over Arkansas' legislative ban on gender-affirming care for minors.
