

Texas Children's Hospital pauses hormone therapies for gender-affirming care after Abbott and Paxton directive

Texas Children's Hospital has "paused" hormone-related prescription therapies for gender-affirming care in response to the controversial directive from state leaders to investigate medical treatments for transgender youth as child abuse, according to a statement from the hospital.

"The mission of Texas Children's Hospital is to create a healthier future for all children, including transgender children, within the bounds of the law," the statement reads. "After assessing the Attorney General's and Governor's actions, Texas Children's Hospital paused hormone-related prescription therapies for genderaffirming services. This step was taken to safeguard our healthcare professionals and impacted families from potential criminal legal ramifications."

Armed with a non-binding opinion by Attorney General Ken Paxton, Gov. Greg Abbott has made it clear that he thinks parents who support gender-affirming care for transgender children should be treated as child abusers. Paxton's opinion last week followed multiple failed attempts by Republican state lawmakers in the GOP-led Texas Legislature to pass measures that would punish parents and health care providers who support gender-affirming care for transgender children.

Abbott and Paxton, who are Republicans, are both seeking re-election and made their announcements shortly before Tuesday's GOP primary.

A Travis County district judge on Wednesday temporarily stopped the state's child welfare agency from investigating possible child abuse charges against the parents of a 16-year-old who underwent gender-affirming health care.

But the court stopped short of blocking such investigations statewide — at least for now.

Lou Weaver, a transgender man and community advocate for transgender children and adults, said very few facilities offer gender-affirming care for children, and Texas Children's is among the biggest programs in Texas that offered it.

"This is a truly frightening time for trans youth and their parents and guardians," he said. "The doors to life-saving health care are literally being shut in their faces."

UT Southwestern's children's hospital in Dallas shut down services for new patients at the end of the last legislative session due to political pressure, Weaver said.

According to <u>reports</u>, GENECIS, a program at Children's Medical Center Dallas that offers hormone treatment for transgender youth, also stopped taking new transgender minor patients for gender-affirming prescriptions.

Weaver said teens who already have a prescription should be OK, but those who haven't begun puberty blockers or hormones would have to seek help elsewhere. He said people in the community are already going into a "headspin," especially because TCH announced the official pause on a Friday afternoon.

They are likely already determining whether they'll have to go out of state or to Mexico for care, he said.



The lawsuit, <u>Dekker</u>, et al., v. <u>Marstiller</u>, et al., was filed in the U.S. District Court for the Northern District of Florida against the Florida Agency for Health Care Administration (AHCA), on behalf of four plaintiffs: August Dekker (he/him) and Brit Rothstein (he/him), as well as two minors identified under pseudonyms, Susan (represented by her parents Jane and John Doe) and K.F. (represented by his mother, Jade Ladue).

"It has been extremely stressful to have to worry about whether I will be able to get the medical care that I need and which is recommended by my doctors. This new Medicaid rule denies me the ability to access treatment that I cannot otherwise afford. Everyone deserves to exist in a way that feels safe, yet this ban will impact so many transgender Medicaid beneficiaries like me with very negative effects on our physical and mental health and our lives. It's truly awful and unfair to feel like the state is targeting your existence," said plaintiff August Dekker, a 28-year-old transgender man from Hernando County, Florida.

The <u>rule</u> adopted by the Florida Agency for Health Care Administration (AHCA), which oversees Florida's Medicaid Program, went into effect on August 21 and has left thousands of transgender people in Florida without access to critical medical care for the treatment of gender dysphoria. AHCA finalized the rule on August 1 after ignoring expert testimony and thousands of public comments during the rule-making process earlier this summer.

"We believe providing our daughter with the medical care that she needs and is recommended by her doctors for her gender dysphoria is imperative to ensure her health and well-being. The state's decision to stop covering medically necessary gender-affirming medical care through Medicaid is tragic. It is cruel and dehumanizing. It's frustrating to know that the same medications and care that are provided to other children for different medical reasons, will not be provided to our child. We are concerned about the message the State of Florida is sending to young transgender people like our daughter by excluding them from the Medicaid coverage to which they otherwise would be entitled simply because of who they are." said Jane and John Doe, parents of plaintiff Susan, a 12-year-old transgender girl, who all are proceeding anonymously.

"Not only is this rule illegal, but it would serve to perpetuate health inequities by eliminating access to safe, reliable healthcare for some of our most marginalized residents. "The new rule adopted by Florida's Agency for Health Care Administration endangers the health, well-being, and very lives of Florida's transgender Medicaid beneficiaries. It represents a cruel and deplorable action; one that is motivated by politics and bias rather than medicine and science. It also represents the complete abdication of AHCA's own

mission statement to "Better Health Care for *All* Floridians." Everyone should have access to essential, medically necessary health care, and this rule excludes some of the people most in need in Florida. We are proud to stand alongside the brave plaintiffs we represent and our partners in challenging this unlawful policy." said **Omar Gonzalez-Pagan**, **Counsel and Health Care Strategist at Lambda Legal**.



AUSTIN, Texas — Lambda Legal, the American Civil Liberties Union, and ACLU of Texas today asked a Texas state court to block the Texas Department of Family and Protective Services (DFPS) from investigating parents who work with medical professionals to provide their adolescent children with medically necessary gender-affirming care.

The lawsuit names Texas Gov. Greg Abbott, who recently issued a directive stating that providing gender-affirming care should be considered a form of child abuse. The suit also names DFPS Commissioner Jaime Masters and DFPS, as defendants. The lawsuit includes claims that these recent directives were issued without proper authority, in violation of the Texas Administrative Procedures Act, the separation of powers requirements of the Texas Constitution, and the constitutional rights of transgender youth and their parents.

"For Governor Abbott and Attorney General Paxton, it seems the cruelty is the point," said **Lambda Legal Senior Counsel Paul Castillo (be/bim)**. "They are joining a politically motivated misinformation campaign with no consideration of medical science and seem determined to criminalize parents seeking to care and provide for their kids, and medical professionals abiding by accepted standards of care for transgender youth. Gender-affirming care for the treatment of gender dysphoria is medically necessary care, full stop. Criminalizing that care and threatening to tear children from their families is unconscionable and terrifying, and cannot stand."

The lawsuit was filed on behalf of an employee of DFPS with a transgender child, her husband, and the teen herself. According to the complaint, this family has had an investigator already arrive at their house. The family has filed the lawsuit anonymously. Dr. Megan Mooney, a licensed psychologist who is considered a mandatory reporter under Texas law and cannot comply with the governor's directive without harming her clients and violating her ethical obligations, is also a plaintiff in the suit.

"No family should have to fear being torn apart because they are supporting their trans child," said **Adri Pérez (they/them)**, **policy and advocacy strategist at the ACLU of Texas.** "A week before an election, Gov. Abbott and Attorney General Ken Paxton issued a partisan political attack that isn't rooted in the needs of families, the evidence from doctors and the expertise from child welfare professionals. Families with trans kids in Texas have been under attack for too long. Genderaffirming health care saved my life, and other trans Texans should be able to access medically

necessary, lifesaving care."

"Our youth, our communities, will not be used as political props," said **Emmett Schelling** (he/him), executive director of Transgender Education Network of Texas (TENT). "We will not allow for these continued efforts to restrict access to life-saving care and criminalize families based on patently false information. To Attorney General Paxton and Gov. Abbott, we will not continue to play a sadistic role in your political theater."

While doctors and medical organizations have been providing gender-affirming care to youth, including transgender youth, for decades, it has increasingly become a target of attacks from state lawmakers. After Arkansas became the first state to pass a ban on gender-affirming care for trans youth last year, a federal court blocked the law from being enforced. While dozens of states have proposed laws similar to what became law in Arkansas — including some like Alabama that have proposed criminal penalties for providing gender-affirming care to youth — Texas is the only state saying providing this lifesaving care could lead to a child being removed from their family and placed in the foster care system.

"These efforts to cut off and criminalize necessary health care for transgender minors are in direct conflict with the recommendations of medical professionals and have nothing to do with what's best for trans youth," said **Chase Strangio (he/him)**, **deputy director for trans justice with the ACLU LGBTQ &HIV Project**. "They may be escalating, but these attacks are not new. Trans youth need you to take the fury you have over what's happening in Texas and share it with lawmakers in every state that is trying to make it harder for trans youth to survive."

A court could rule as soon as Tuesday. The lawsuit was filed by the American Civil Liberties Union Jon L. Stryker and Slobodan Randjelović LGBTQ &HIV Project, the ACLU Women's Rights Project, the ACLU of Texas, Lambda Legal, and the law firm of Baker Botts LLP.

Just circling back on this - would love to get any thoughts you have!

With a recent update, the HR department of this hospital has advised that peer reviews/observations are sufficient for documenting proficiency of interpreters; again, to minimize their exposure to issues around disparate impact. But peer review seems very subjective and may not be available for all languages. The interpreter manager would like to implement third party assessments from an independent entity, both for staff interpreters and to qualify bilingual clinical staff who speak to LEP patients without the use of an interpreter. But it doesn't seem there's anything from OCR, CMS or HHS specifically on this issue which is why she reached out to me.

I'm not sure if you're the right person to ask but I thought I'd start with you. I got the below question from a manager of an interpreter department at a hospital.

The individual leads the interpreting department. She's had five years total at the hospital, 2 as the interpreter manager. She has a team of 30 interpreters; eight nationally certified ASL interpreters, 1 CoreCHI Mandarin interpreter, and the rest are Spanish interpreters (three hold their CCHI).

There is no record of proficiency assessments for any interpreter in their system and no competencies developed for interpreters. There also is no process in place to qualify bilingual clinical staff to speak directly to patients in their preferred language without the use of an interpreter.

The interpreter manager conducted spoken language interpreter proficiency assessments through two external organizations (CCCS and ASL interpreter proficiency assessments through UpHealth/Martti (our VRI/OPI vendor)) from May - Aug 2022. Two Spanish interpreters and two ASL interpreters did not pass the proficiency assessments. The Spanish interpreters were noted by the assessing organization as potentially being dangerous to patient safety.

The interpreter manager worked with the HR department to develop a 90-day professional development plan for these two interpreters which included: peer-shadowing (being shadowed and shadowing others), coaching, a company paid 40-hour medical interpreter training through ALTA, re-assessment at 45 days with CCCS and reassessment again at 90 days with ALTA (to ensure no bias in assessment).

The HR department is now saying that the interpreter department cannot include any information about the 3rd party assessments in any corrective action for anyone on the interpreter team and can't use a 3rd party assessment tool to ensure proficiency prior to hiring future interpreters. Their reason is because these assessments are not "legally validated and, specifically, they haven't been legally validated for disparate impact." They shared in part:

...non validated assessments is something that is a strict no for either the hiring process or proficiency test. You may have to research on various alternative processes or legally valid assessments recognized by other organizations to evaluate the proficiency of the interpreters.

They also are not in support of a requirement that all spoken language interpreters to be nationally certified within 18-months of hire because certification is not a CMS guideline.

There are other issue about the competency of bilingual providers but the issue is starting with interpreters.

It seems this may bring in employment law issues but given the civil rights implications of having not qualified interpreters providing services, it seems it's also an OCR issue.

I can also reach out to folks at CMS given hospital accreditation but thought I'd start with you to see if this has come up previously.



Texas Children's Hospital pauses hormone therapies for gender-affirming care after Abbott and Paxton directive

Texas Children's Hospital has "paused" hormone-related prescription therapies for gender-affirming care in response to the controversial directive from state leaders to investigate medical treatments for transgender youth as child abuse, according to a statement from the hospital.

"The mission of Texas Children's Hospital is to create a healthier future for all children, including transgender children, within the bounds of the law," the statement reads. "After assessing the Attorney General's and Governor's actions, Texas Children's Hospital paused hormone-related prescription therapies for genderaffirming services. This step was taken to safeguard our healthcare professionals and impacted families from potential criminal legal ramifications."

Armed with a non-binding opinion by Attorney General Ken Paxton, Gov. Greg Abbott has made it clear that he thinks parents who support gender-affirming care for transgender children should be treated as child abusers. Paxton's opinion last week followed multiple failed attempts by Republican state lawmakers in the GOP-led Texas Legislature to pass measures that would punish parents and health care providers who support gender-affirming care for transgender children.

Abbott and Paxton, who are Republicans, are both seeking re-election and made their announcements shortly before Tuesday's GOP primary.

A Travis County district judge on Wednesday temporarily stopped the state's child welfare agency from investigating possible child abuse charges against the parents of a 16-year-old who underwent gender-affirming health care.

But the court stopped short of blocking such investigations statewide — at least for now.

Lou Weaver, a transgender man and community advocate for transgender children and adults, said very few facilities offer gender-affirming care for children, and Texas Children's is among the biggest programs in Texas that offered it.

"This is a truly frightening time for trans youth and their parents and guardians," he said. "The doors to life-saving health care are literally being shut in their faces."

UT Southwestern's children's hospital in Dallas shut down services for new patients at the end of the last legislative session due to political pressure, Weaver said.

According to <u>reports</u>, GENECIS, a program at Children's Medical Center Dallas that offers hormone treatment for transgender youth, also stopped taking new transgender minor patients for gender-affirming prescriptions.

Weaver said teens who already have a prescription should be OK, but those who haven't begun puberty blockers or hormones would have to seek help elsewhere. He said people in the community are already going into a "headspin," especially because TCH announced the official pause on a Friday afternoon.

They are likely already determining whether they'll have to go out of state or to Mexico for care, he said.

Texas Children's Hospital pauses hormone therapies for genderaffirming care after Abbott and Paxton directive

Texas Children's Hospital has "paused" hormone-related prescription therapies for gender-affirming care in response to the controversial directive from state leaders to investigate medical treatments for transgender youth as child abuse, according to a statement from the hospital.

"The mission of Texas Children's Hospital is to create a healthier future for all children, including transgender children, within the bounds of the law," the statement reads. "After assessing the Attorney General's and Governor's actions, Texas Children's Hospital paused hormone-related prescription therapies for genderaffirming services. This step was taken to safeguard our healthcare professionals and impacted families from potential criminal legal ramifications."

Armed with a non-binding opinion by Attorney General Ken Paxton, Gov. Greg Abbott has made it clear that he thinks parents who support gender-affirming care for transgender children should be treated as child abusers. Paxton's opinion last week followed multiple failed attempts by Republican state lawmakers in the GOP-led Texas Legislature to pass measures that would punish parents and health care providers who support gender-affirming care for transgender children.

Abbott and Paxton, who are Republicans, are both seeking re-election and made their announcements shortly before Tuesday's GOP primary.

A Travis County district judge on Wednesday temporarily stopped the state's child welfare agency from investigating possible child abuse charges against the parents of a 16-year-old who underwent gender-affirming health care.

But the court stopped short of blocking such investigations statewide — at least for now.

Lou Weaver, a transgender man and community advocate for transgender children and adults, said very few facilities offer gender-affirming care for children, and Texas Children's is among the biggest programs in Texas that offered it.

"This is a truly frightening time for trans youth and their parents and guardians," he said. "The doors to life-saving health care are literally being shut in their faces."

UT Southwestern's children's hospital in Dallas shut down services for new patients at the end of the last legislative session due to political pressure, Weaver said.

According to <u>reports</u>, GENECIS, a program at Children's Medical Center Dallas that offers hormone treatment for transgender youth, also stopped taking new transgender minor patients for gender-affirming prescriptions.

Weaver said teens who already have a prescription should be OK, but those who haven't begun puberty blockers or hormones would have to seek help elsewhere. He said people in the community are already going into a "headspin," especially because TCH announced the official pause on a Friday afternoon.

They are likely already determining whether they'll have to go out of state or to Mexico for care, he said.


