I'm writing to ask whether we can include some of my colleagues on the NTP for the fluoride briefing with you at 3 pm on June 1st. The NTP is a collaborative effort with Drs. John Howard and his colleagues at the CDC (NIOSH), Jackie O'Shaughnessy and her colleagues at the FDA (NCTR), and Brian Berridge and his colleagues (including Mary Wolfe) at the Division of the NTP at NIEHS.
