ABOUT HHS'S ACTIONS TO PROTECT PARENTS' RIGHTS IN CHILDREN'S HEALTH DECISIONS

On December 3, 2025, the U.S. Department of Health and Human Services [announced](#) a series of actions to protect the integrity of parental rights in pediatric medicine. These actions include an investigation into a Midwestern school that illegally vaccinated a child without parental consent, a [Dear Colleague letter](#) reminding healthcare providers of their duty to provide parental access to child health information, and a requirement that grant recipients must fully comply with federal and state parent-consent laws for services at HRSA-supported health centers.
